The material PU-W/1 Multifil has been tested for total migration in accordance with Regulation (EU) No. 10/2011 as amended for repeated contact with foodstuffs, which includes heating to 70°C for up to 2 hours or to 100 °C for up to 15 minutes and which does not involve any long-term storage at room temperature or refrigeration follows.

According to the results of the tests carried out the sample is suitable for contact with moist, acidic and non-greasy foods. The contact with fatty foods is limited to products such as bakery products, chocolate, butter / margarine, fish, meat and meat products, fried / roasted / dried foods, which are not in an oil-containing medium (foodstuffs for which in Regulation (EU) No. 10/2011, Annex III, Tab. 2 a correction factor for the food simulant D2 of at least 2 is provided). The tested sample corresponds under the above mentioned restrictions regarding the total migration also complies with Regulation (EU) No. 1935/2004 in the current version.

The contact time and contact temperatures were selected to represent the actual conditions of our products.

The material has been tested in accordance with the requirements of Commission Regulation (EC) No. 2023/2006 on Good Manufacturing Practice for Materials and Articles intended to come into contact with food.
